**GENERAL CONDITIONS** The following terms of sale are valid for each offer, sale, supply. The customer, by placing a purchase order declares to officially agree in accordance with our terms of sale. Different terms of sale are valid if specifically agreed in writing.

**PURCHASE ORDERS** The customer, by purchasing through written confirmation only, declares to agree fully with our terms of sale.

**PRICES** The mentioned prices on offers, order confirmations, invoices, are EX-WORKS, unless specified.

**SUPPLIES** Goods are sold EX-WORKS and they're at your own risk after leaving our premises. For circumstances beyond our control, difficulties of production, lack of raw materials, missing supply of fundamental goods from our suppliers, allow us to withdraw totally or partially the agreed term of delivery. The missing supply of goods within the agreed terms does not justify the request claim for damages or the cancellation of the supply. Partial shipments can not be rejected by the customer.

**CLAIMS** Claims are accepted in accordance with our warranty policy only.

**WARRANTY** The warranty of our products is valid for defected material and wrong manufacturing and it is limited to the free replacement/repair of the defected parts after the approval of our technical team at O.M.C. 2 DIESEL S.p.A. The warranty is not valid neither for the natural wear of the parts nor by a wrong use, wrong compliance of instruction assembly.

**PAYMENTS** Terms of payment are established by O.M.C. 2 DIESEL S.p.A and are mentioned on offers, order confirmations, invoices. Our Company reserves the right to amend the payment whenever we deem it is necessary.

**PROPERTY OF GOODS** The goods are property of O.M.C. 2 DIESEL S.p.A. until the payment has been cashed.

**PLACE OF JURISDICTION** Any controversy will be taken into consideration and handled by the place of Jurisdiction of Brescia.
